808 EQ Earbuds:

808 EQ earbuds offer great sound and voice quality in compact metal housing, with spiral support eartips for a comfortable, snug fit, and an inline mic with control switch. They will be available in two (2) colors: black (HPA85BK) and red (HPA85WH), featuring 9.2mm dynamic transducer drivers that provide deep bass with minimal distortion. The EQ earbuds have a notangle premium rayon braided OFC cable, three sizes of snug-fitting, comfortable spiral supported eartips, and a carrying case. 808 EQ earbuds will be available this September with an MSRP of \$59.99.

808 Canz Wireless Bluetooth Speaker:

808 Canz wireless Bluetooth speakers provide big sound in a little package, providing the punchiest 2 watts of sound around via a Bluetooth wireless or a line-in connection. They will be available in three (3) colors: red (SP880RD), blue (SP880BL) and silver (SP880SL). Canz speakers feature a rechargeable lithium polymer battery providing 6 hrs of playtime at normal volume from a single charge. Canz speakers support Bluetooth v2.1 (profile A2DP), with a 30-foot wireless operating range, LED pairing indicator, and pairing button. Each Canz speaker comes with a USB charging cable and an Aux-in cable. 808 Canz Wireless Bluetooth Speakers will be available this August with an MSRP of \$39.99.
