RC250 also features 1 USB charging interface that supports iPhone, Android, eReaders and most tablets, clock radio functions such as dual wake and FM radio, as well as a .9" LED display. The RC250 will be available in May of 2013 and will retail for \$29.99.

Geise continued, "In our market research for Soundflow, we've found overwhelming interest in the concept from consumers. To turn this interest into action, we've identified locations around the home where sound can be added to a strategic spot. The nightstand, for example, is an area of the home that has multiple functions and limited space. Still, consumers increasingly ask their nightstands to accommodate a smartphone as well. Our Soundflow wireless audio tabletop and clock radio pieces add smartphone music and charging to traditional nightstand functionality in a single item, starting at less than \$30. We've designed Soundflow to add simplicity, not clutter."
