Using Your Remote Control

Remote Starting Your Vehicle

To activate the remote start, press and release the Ω button two (2) times. The vehicle will start and run the predetermined time set up during installation (5 to 60 minutes selectable).

Door Unlock

While the engine is running press, and release and hold the Ω button or three (3) seconds. Unlock is only available while the vehicle is remote started.

Remote Start Shutdown

Press and release the Ω button two times to turn the vehicle off. Pressing the vehicle's brake will also shutdown the remote start.

Entering the Vehicle while it is Running via Remote Start (Optional)

- 1. Unlock the vehicle's doors.
- 2. Enter the vehicle. DO NOT PRESS THE BRAKE PEDAL!
- Insert the key into the ignition switch and turn to the ON or RUN position.
- Press the brake pedal. The remote starter will disengage and the vehicle will operate normally.

NOTE: This feature may not be available on all vehicle makes/models. In some vehicle applications the remote start will shut down upon entering the vehicle and the engine will stop running. For these applications it will be necessary to restart the vehicle normally. Refer to installing dealer for details.

Preheating or Precooling the Vehicle's interior

Before exiting the vehicle, set the temperature controls to the desired setting and operation. After the system starts the vehicle, the heater or air conditioner will activate and heat or cool the vehicle's interior to your setting.

Remote Start Service Mode

For safety, the remote start feature can be disabled to prevent accidental starting while the vehicle is being serviced.

To engage Remote Start Service Mode

- Press and hold the valet button.
- 2. Cycle the vehicle's ignition ON/OFF three (3) times.
- 3 Release the valet button

The LED will begin to flash two (2) short flashes followed by one (1) long flash to indicate Remote Start Service Mode is active. Repeat steps 1-3 above to disengage Service Mode.

Using Your Security System (Optional)

System Arm

To arm and lock the vehicle doors press and release the Ω button One (1) time. The LED on the antenna will flash one time while armed.

System Disarm

To disarm and unlock the vehicle doors press and release the Ω button two (2) times.

Remote Starting Your Vehicle

To activate the remote start, press and hold the Ω button for three (3) seconds. The vehicle will start and run the predetermined time set up during installation (5 to 60 minutes selectable).

Remote Start Shutdown

Press and hold the Ω button for three (3) seconds to turn the vehicle off. Pressing the vehicle's brake will also shutdown the remote start.

System Override

To disarm the system without the use of the remote control, locate the valet button on the windshield mounted antenna.

- Enter the vehicle
- Turn the vehicle ignition to the ON position.
- 3. Press and release the valet button on the antenna one (1) time.

The system is now disarmed and will remain disarmed until the Ω button is pressed.

Valet Mode

Valet mode allows the user to Lock or Unlock the vehicle without Arming the security system. To enter or exit valet mode:

- 1. Turn the vehicle ignition to the ON position.
- Press and hold the valet button for five (5) seconds. The LED on the antenna will turn on solid.

Programming Your Remote Control

- Cycle the vehicle's ignition ON.
- 2. Press and release the valet button three (3) times.
- 3. Press the O button of each remote control you wish to program, the parking lights will flash to confirm each transmitter.
- Turn the vehicle ignition OFF.

NOTE: This system has one (1) button programming which programs all channels of the system.

NOTE: The system will hold up to four (4) remote controls in memory, programming a 5th remote will erase the oldest remote in memory.

Replacing The Batteries

1 Button Remote Control - Model 181BP

The CR2032 battery inside each remote control should last approximately 1 year under normal use. When the battery becomes weak you will notice the remote control range (the distance from the vehicle the remote control will work) deteriorate and the small LED on the remote control will dim. To replace the remote control batteries:

- 1. Using a coin, disassemble the halves of the remote control.
- Remove the old battery, observing the +/- symbols on the batteries and replace with a new battery.
- 3. Reassemble the halves of the remote control.
- 4. Test operation of the remote control.
